* Volumetric weight.

Volumetric weight is the volume that a parcel takes up during transport. The rate for shipments outside Europe is calculated as follows: base rate + number of kilos* (price per kilo + energy surcharge). This method ensures that shipments that take up more space or weigh more are charged at a higher rate.

* Number of kilos: the price is based on the higher value of actual weight or volumetric weight. Volumetric weight = volume (dm³) / 6.

Surcharges.

Energy surcharge.

High energy and fuel prices have a major impact on consumers and businesses. As a result of this increase an energy surcharge applies.

Peak surcharge.

PostNL charges a peak surcharge to safeguard delivery quality for parcels and letterbox parcels in the busiest period of the year.

Large parcel surcharge.

Research shows that half of all parcels shipped contain air, which takes up unnecessary space. By reducing this we create more logistics capacity and lower CO2 emissions. For parcels larger than 50 dm³ within the Netherlands and the EU a surcharge applies.

Large parcel surcharge is charged in combination.

Return to sender after refusal or undeliverable.

From 1 January 2026 a surcharge applies to PostNL shipments within the Netherlands and to Belgium that are returned because they cannot be delivered. This may be due to irregular dimensions or incorrect addresses.

Surcharge: rates in line with the original shipping rate (charged per parcel).





Non standard processing.

A parcel that due to its nature, shape or packaging must be processed by hand. See [this handout](#) for a complete overview of the criteria.

Tips to avoid the surcharge:

- Use sturdy rectangular boxes.
- Place the shipping label at the top right on the longest side of the box.
- Fill empty space well so that the contents do not move.

Heavy parcel.

Shipments in this weight class require extra care and manual handling during sorting and delivery.

Exceeding maximum parcel dimensions.

For parcels that exceed the maximum size and or maximum weight PostNL charges a freight surcharge.

Tips to avoid the surcharge:

- Use strong packaging that keeps its shape during transport.
- Stay well within the maximum size.

Surcharge: € 87,95

Not (correctly) pre-registered surcharge.

PostNL charges a surcharge for shipments that are not pre-registered correctly. This applies, for example, when the address is incorrect or incomplete, or when the barcode is damaged.

Here's how to avoid this surcharge:

- Check the address. Make sure it is complete and correct.
- Use a barcode that can be scanned properly.
- Use barcodes within 10 days.
- Never reuse barcodes.

Letterbox parcel too large / too heavy.

PostNL charges a surcharge for letterbox parcels that exceed the standard size.

SurchARGE.

Energy surcharge.

DPD charges a variable energy surcharge on the shipment rate, adjusted to fluctuating energy prices.

SurchARGE: variable, see dpd.com/nl/en/fuel-surchARGE/ for the current energy surcharge.

Tire surcharge.

Tires to Finland, Norway and Denmark that are not delivered in cardboard packaging will be packed by DPD. DPD charges a surcharge for this.

SurchARGE: € 3,35 per tire

Peak surcharge tires.

For sending tires a peak surcharge applies from 1 March to 31 May and from 24 September to 24 December.

SurchARGE: € 1,70 per tire

NSP (Non Standard Parcel).

A parcel is considered a Non Standard Parcel (NSP) if it:

- Is longer than 130 cm and shorter than 175 cm (length or diagonal)
- Has a weight between 20 and 31,5 kg
- Has an unstable or irregular shape (sphere, cylinder, roll)
- Is not properly packaged according to the packaging guidelines
- Has a missing or poorly readable label, or requires additional manual handling or sorting

Category A: NSP parcels are less than 10% of the total. € 2,24 per NSP parcel.

Category B: NSP parcels form 10% to 15% of the total. € 3,54 per NSP parcel.

Category C: NSP parcels make up 15% to 50% of the total. € 5,84 per NSP parcel.

Category D: NSP parcels are more than 50% of the total. € 7,84 per NSP parcel.





Exceeding dimensions and weight NP parcel.

DPD applies maximum dimensions and weights for parcels. If these exceed the following limits a surcharge is applied:

- Length or diagonal longer than 175 cm
- Weight over 31,5 kg
- Girth greater than 300 cm.

When this surcharge applies the NSP surcharge does not apply

Surcharge: € 46,50 per parcel

Exceeding dimensions and weight KP parcel.

DPD applies maximum dimensions and weights for small parcels. If the following limits are exceeded a surcharge is applied:

- Length or diagonal longer than 50 cm
- Weight over 3 kg
- Girth greater than 111 cm.

Surcharge: € 7,50 per parcel

Age check.

Surcharge for checking whether the recipient of the parcel is 18 years or older. Mandatory for delivery of alcohol and tobacco in the Netherlands.

Surcharge: € 1,84 per parcel

Returns of non deliverable or refused parcels.

Parcels that cannot be delivered, are refused by the recipient or are not collected at a Pickup parcelshop within 7 days are returned to the sender. DPD charges a surcharge for these returns.

Surcharge: DPD business delivery rate (DPD Classic) + € 2,85



**Toll surcharge.**

DPD charges two toll surcharges: Belgium (to and through Belgium) and Germany (to and through Germany). The percentages are charged per parcel and shown as a total on the invoice.

4,4 % per parcel to Germany

2,95 % per parcel through Germany

Surcharges.

Fuel surcharge.

UPS charges a fuel surcharge on every shipment. The fuel surcharge is calculated on the base rate including the surcharge "Residential delivery".

Surcharges: the most recent and complete information can be found on ups.com.

Residential delivery.

For shipments to residential addresses UPS charges a surcharge.

Surcharges: € 0,42 (MyParcel rate)

Shipping cost correction.

UPS charges a surcharge when the actual weight of the shipment differs from the declared weight. This surcharge only applies if the correction is more than 25% of the original shipping costs. Additional services and costs such as the fuel surcharge are not included in this calculation.

Surcharges: € 1,50 per shipment or 8% of the total amount of the shipping cost correction, whichever is higher.

Payment of import duties.

The recipient receives a payment link from UPS to pay the import charges. If these charges are not paid in advance they must be paid upon delivery. UPS charges a surcharge to the recipient for this.

Important: in some cases UPS will still deliver the parcel even if the import duties have not been paid. In that case the import duties will be charged to you afterwards.

Surcharges: 12 US dollars (if paid at the door)

Handling of shipments to the USA.

For shipments to the USA a surcharge of 2,50 US dollars per shipment applies. This covers the extra costs for processing by US customs at busy sorting locations.
